*LOCAL GOVERNMENT CODE <u>TITLE 5. MATTERS AFFECTING PUBLIC OFFICERS AND EMPLOYEES</u> <u>CHAPTER 176. DISCLOSURE OF CERTAIN RELATIONSHIPS WITH LOCAL GOVERNMENT</u> <u>OFFICERS; PROVIDING PUBLIC ACCESS TO CERTAIN INFORMATION</u>

Sec. 176.003. CONFLICTS DISCLOSURE STATEMENT REQUIRED. (a) A local government officer shall file a conflicts disclosure statement with respect to a vendor if:

- (1) the vendor enters into a contract with the local governmental entity or the local governmental entity is considering entering in to a contract with the vendor; and
- (2) the vendor:
 - (A) has an employment or other business relationship with the local government officer or a family member of the officer that results in the officer or family member receiving taxable income, that exceeds \$2,500 during the 12-month period preceding the date that the officer become aware that:
 - (i) a contract between the local governmental entity and vendor has been executed; or
 - (ii) the local governmental entity is considering entering into a contract with the vendor;
 - (B) has given to the local government officer or a family member of the officer one or more gifts that have an aggregate value of more than \$100 in the 12-month period preceding the date the officer becomes aware that:
 - (i) a contract between the local governmental entity and vendor has been executed; or
 - (ii) the local governmental entity is considering entering into a contract with the vendor; or
 - (C) has a family relationship with the local government officer.

1. CALL TO ORDER

Mr. Tobe Shields called the meeting to order at 1:30 p.m. and noted that a quorum was present.

2. INVOCATION

Mr. Tobe Shields gave the invocation.

3. PUBLIC COMMENT

No public comments were made.

4. MINUTES

Mr. Sal Rivera moved to accept the minutes from February 23, 2023. Mr. Winston Sauls seconded the motion; the motion carried by unanimous vote.

5. VOUCHERS

Dr. John Howard moved to approve the vouchers for the month of February, 2023. Mr. Rank Cogdell seconded the motion; the motion carried by unanimous vote.

6. 2022 AUDIT PRESENTATION AND ACCEPTANCE

Mr. Trent Taylor informed the board the PRPC has an audit performed annually under the required standards of the American Institute of Certified Public Accountants, the U.S. General Accounting Office, the U.S. Office of Management and Budget, and the State of Texas Uniform Grant Management Standards. The Panhandle Regional Planning Commission engages the services of an independent CPA firm, Edgin, Parkman, Fleming and Fleming to complete audit services on a comprehensive annual financial report. A copy of the 2022 ACFR report is included in this agenda packet. The PRPC anticipates no issues or problems with the audit and request the Board of Directors acceptance of the Year End 9/30/2022 Annual Comprehensive Financial Report.

Mr. Sal Rivera moved to accept the 2022 Annual Comprehensive Financial Report. Judge Ronnie Gordon seconded the motion; the motion carried by unanimous vote.

7. REVIEW AND CONSIDER FOR APPROVAL PRPC INVESTMENT OPTIONS

The PRPC has historically kept the PRPC fund balance in Money Market accounts that are backed by bonds held by the bank. At the Board of Directors' Request, we have investigated various investment options, and evaluated the amounts that could be invested and additional controls that will need to be enacted for each option. The options reviewed today with the audit committee are:

- Continue with secured Money Markets
- Laddering CD's
- Laddering CDAR CD's
- Laddering Treasuries
- Bond Managers

The PRPC Audit Committee's investment recommendations were brought before the PRPC Board for final review and approval.

Dr. John Howard moved to approve the option recommended by the PRPC Audit Committee. Mr. Pat Sims seconded the motion; the motion carried by unanimous vote.

8. <u>DISPUTE RESOLUTION CENTER INTERLOCAL COOOPERATION CONTRACT</u> FOR ALTERNATIVE DISPUTE RESOLUTION FUNDING PROVIDED IN TEXAS GOVERNMENT CODE 135

Mr. Christian Campbell informed the board as discussed in the last meetings, in accordance with section 135 of the Texas Local Government Code, PRPC is reaching out to the 26 County Courts of the Panhandle to try and establish an interlocal agreement whereby the Dispute Resolution Center (DRC) is agreeable to provide dispute resolution services for the county courts. The County can agree through the use of an interlocal agreement to remit county funds to DRC in accordance with the following sections of the Texas Local Government Code:

135.101: \$213 on filing any civil case except a probate, guardianship, or mental health case. \$35 on any action other than an original action for a case. <u>7.0423% to county dispute resolution fund.</u>

135.102: \$223 on filing any probate, guardianship, or mental health case. \$75 on any action other than an original action for a case. <u>6.7265% to county dispute resolution fund.</u>

135.103: In addition to all other fees and court costs, a person shall pay a local consolidated filing fee of \$33 on filing of any civil case in a justice court. <u>15.1515% to county dispute resolution fund.</u>

Several counties are currently in various stages of adopting the Interlocal Agreement with the Panhandle Dispute Resolution Center to utilize funds allocated for dispute resolution services in accordance with Texas Local Government Code 135. Counties that have passed or are considering this agreement include: Armstrong & Hutchinson Counties. Staff recommends that the Board of Directors consider favorable approval of the Interlocal Agreement with the above referenced counties in relation to dispute resolution and Texas Government Code 135 by authorizing the Executive Director to execute this document. Mr. Winston Sauls moved to approve the Interlocal Agreement with the above referenced counties. Judge Ronnie Gordon seconded the motion; the motion carried by unanimous vote.

9. PANHANDLE REGIONAL 9-1-1 NETWORK QUARTERLY REPORT

Mr. John Schaumburg informed the board as stipulated in the agreement between Panhandle Regional Planning Commission and the Commission on State Emergency Communications (CSEC), the Panhandle 9-1-1 Network must establish and accomplish certain goals and objectives. In order to check progress throughout the year, we are required to submit to CSEC a quarterly performance report that includes 9-1-1 call volumes, monitoring results, network outage reports, system testing, and the status of equipment replacement. The following items make up the key points of the FY23 Q2 performance report covering December, January, and February.

- There were 25,239 9-1-1 calls received from the 21 regional call centers of which 19,702 being wireless or 78%.
- Staff monitored seventeen Public Service Answering Points (PSAPs) with no findings.
- PSAP staff and PRPC staff performed 1,746 Network test calls.
- There were four outages during this quarter.
- The region received 1,746 text messages during this period, with the vast majority as test texts.

Staff recommends that the PRPC Board of Directors accept the performance report as submitted for the second quarter of FY 2023 covering December, January, and February.

Dr. Bill Hallerberg moved to accept the performance report for the second quarter of FY 2023. Judge Harold Keeter seconded the motion; the motion carried by unanimous vote.

10. PANHANDLE REGIONAL 9-1-1 NETWORK INTERLOCAL AGREEMENTS FOR E9-1-1 SERVICE 7 PSAP EQUIPMENT

Mr. John Schaumburg informed the board a requirement of the Commission on State Emergency Communications (CSEC) is to maintain interlocal contracts between the Texas Councils of Government and the agencies responsible for each 9-1-1 PSAP or Public Safety Answering Point.

The interlocal agreements explain the requirements of both the PRPC and the agency responsible for the PSAP. These contracts renew in conjunction with the State's fiscal biennium. This new two-year cycle begins September 1st, 2023. As we are nearing a new funding cycle, the old contracts will soon expire and we have begun the process of renewing these agreements with the 21 cities or counties that are responsible for operating the program's 9-1-1 call taking centers. The only change to the agreements will be to renew the term of the document to expire with the next biennium or August 31st of 2025 in Article 12 page 7. Staff recommends the PRPC Board of Directors authorize the Executive Director to execute interlocal agreements for 9-1-1 service and public safety answering point equipment with 21 regional Cities and Counties operating 9-1-1 public safety answering points.

Mr. Kerry Symons moved to authorize the Executive Director to execute interlocal agreements for 9-1-1 service and public safety answering point equipment with 21 regional Cities and Counties operating 9-1-1 public safety answering points. Mr. Winston Sauls seconded the motion; the motion carried by unanimous vote.

11. EMERGENCY NOTIFICATION SYSTEM 9-1-1 DATABASE USE INTERLOCAL AGREEMENT WITH SHERMAN COUNTY

Mr. John Schaumburg informed the board Sherman County recently approached staff regarding their desire to contract with their vendor, (Genasys Inc.) for emergency notification services. Sherman County has requested to use the 9-1-1 addressing database to provide current telephone numbers and their associated address records to Genasys Inc. to be used for the vendor's emergency callout function.

This data is not subject to public inspection and is confidential in accordance with Texas Health and Safety Code, Section 771.061 (a). The Commission on State Emergency Communications (CSEC) established rule 251.13 to allow the use of this data for emergency notification services, but several conditions must be met. Sherman County must enter into an Interlocal Agreement, which stipulates that both Sherman County and their vendor, Genasys Inc., must maintain the confidentiality of the provided 9-1-1 database. They also agree that use of the data be restricted to the emergency notification services. Once the agreements are all approved, PRPC will formally request authorization from CSEC. Staff supports this arrangement and feels that it would benefit the residents of Sherman County. PRPC staff recommends that the Board of Directors authorize the Executive Director of the PRPC to execute an Interlocal Agreement with Sherman County to have access to 9-1-1 database information for an emergency notification system.

Mr. Pat Sims moved to authorize the Executive Director to execute an Interlocal Agreement with Sherman County to have access to 9-1-1 database information for an emergency notification system. Mr. Juan Cantu seconded the motion; the motion carried by unanimous vote.

12. ECONOMIC DEVELOPMENT ADVISORY COMMITTEE APPOINTMENTS

Ms. Paige Goodell informed the board the Panhandle Regional Planning Commission was named as the Economic Development District for the Texas Panhandle by the U.S. Economic Development Administration (EDA) in 1978. Every three years PRPC seeks funding from EDA to facilitate the planning and implementation of economic development related strategies in the Texas Panhandle. Currently, the Economic Development District is in the second year of its three-year planning grant.

All counties are eligible for funding through EDA programs as long as they meet the EDA distressed criteria (unemployment or per capita income) at the time of the project grant application. The makeup of the committee this year will be representatives from the eighteen counties designated as distressed at the time of the renewal of the PRPC Planning Grant application. They include the following counties: Briscoe, Castro, Childress, Collingsworth, Deaf Smith, Donley, Gray, Hall, Hansford, Hartley, Hutchinson, Moore, Ochiltree, Oldham, Parmer, Potter, Swisher, and Wheeler along

with the other noted ex-officio members continuing terms for continuity and the likelihood that their counties will again be noted as distressed in the near future. Staff recommends approval by the PRPC Board of Directors of the presented slate of nominees to serve on the Economic Development Advisory Committee.

Mr. Kerry Symons moved to approve the presented slate of nominees to serve on the Economic Development Advisory Committee. Judge Harold Keeter seconded the motion; the motion carried by unanimous vote.

13. TEXAS COMMUNITY DEVELOPMENT PROGRAM AGREEMENT AMENDMENT DEVELOPMENT AND MANAGEMENT SERVICES INTERLOCAL CONTRACTS

Mr. Alex Guerrero informed the board the Texas Department of Agriculture (TDA) has long been the funding agency for the Community Development Block Grant (CDBG) Program in the State of Texas. In late 2020 and early 2021, TDA solicited applications to the 2021/2022 TxCDBG program and PRPC assisted over 20

communities in the Panhandle to write, develop and submit applications to this longstanding program for basic water and sewer infrastructure improvements.

This agenda item is to allow for the authorization of the Interlocal Amendment to carry out the administrative function and project management activities should the below projects receive grant funding. The two remaining panhandle communities are Cactus and Quitaque that are likely to receive a grant award.

This list includes: project type, amount of TxCDBG funding, the match amount committed by each community, and the amount that will be paid to the PRPC for general administration functions associated with the grant. PRPC staff recommends that the Board of Directors authorize the Executive Director of the PRPC to execute amendments to the Interlocal Cooperation Contracts should the above noted communities receive a TxCDBG contract for PRPC to provide TxCDBG administration services.

Judge Christy Dyer moved to authorize the Executive Director to execute amendments to the Interlocal Cooperation Contracts should the two above mentioned cities receive a TxCDBG contract for PRPC to provide TxCDBG administration services. Dr. Bill Hallerberg seconded the motion; the motion carried by unanimous vote.

14. STATE HOMELAND SECURITY PROGRAM PROJECT PRIORITIZATION APPROVAL

Ms. Lori Gunn informed the board On March 14th, the Panhandle Regional Emergency Management Advisory Committee (PREMAC) met to evaluate the State Homeland Security Program (SHSP) proposals submitted for consideration under the Panhandle's FY23 SHSP grant program. In total, the PREMAC evaluated nine applications. After considering the written proposals and hearing the oral presentations made by each of the applicants, the PREMAC recommended that the nine projects be prioritized as shown below.

Unlike last year, the Office of the Governor's Homeland Security Grants Division (HSGD) did not provide each Council of Government their Regional Budget Estimate (RBE) for the local projects. However, we were told that we could estimate the allocation to be similar to what the region received the prior year. This allowed PRPC staff to give the PREMAC a better idea of what to expect by way of awards for those nine (9) projects that the PREMAC was prioritizing.

Even with this estimate, we still are not sure if this will be the final amount for the region, so we have given the HSGD a plan for these projects should the amount come in at various percentages points of the estimate. This uncertainty of the funding situation makes the next part of the PREMAC's recommendations all the more important. PRPC staff recommends the PRPC Board of Directors consider approval of the FY23 State Homeland Security Program project prioritizations and funding instructions developed and recommended by the Panhandle Regional Emergency Management Advisory Committee.

Dr. John Howard moved to approve the FY23 State Homeland Security Program project prioritizations and funding instructions developed by the PREMAC Committee. Mr. Juan Cantu seconded the motion; the motion carried by unanimous vote.

15. <u>PANHANDLE REGIONAL EMERGENCY PREPAREDNESS CONFERENCE</u> <u>REGISTRATION MEMORANDUM OF UNDERSTANDING WITH TEXAS A&M</u> <u>ENGINEERING EXTENSION</u>

Ms. Lori Gunn informed the board The Panhandle Regional Emergency Preparedness (PREP) Conference is an annual conference hosted by the Panhandle Regional Planning Commission's Panhandle Regional Emergency Management Advisory Committee (PREMAC). The purpose is to help our various disciplines evolve their current mission and explore affordable methods to become more resilient. Over these last 13 years of the conference; first responders, elected officials/city management, medical personnel, emergency managers, industry partners, volunteers, and many other disciplines have attended this conference. Speakers from all over the country have presented a variety of topics that aid in the all-hazard planning needed to help our communities in times of disasters.

Under this memorandum of agreement, PRPC will invoice TEEX for all student fees collected minus four percent (4%) for each paying participant. The 4% covers TEEX costs from credit card transactions. These fees are in place to cover the cost of food and speakers and their travel. As with previous years, volunteer responders are free. Included with this agenda item is a draft of the Memorandum of Agreement with TEEX for the PREP Conference scheduled for September 21st. PRPC Staff recommends the authorization of the Executive Director to execute a memorandum of understanding with the Texas A&M Engineering Extension for registration services for the Panhandle Regional Emergency Preparedness Conference.

Judge Rank Cogdell moved to authorize the Executive Director to execute a memorandum of understanding with Texas A&M Engineering Extension for registration services for the PREP conference. Mr. Winston Sauls seconded the motion; the motion carried by unanimous vote.

BACKGROUND

Pursuant to the Public Funds Investment Act which was passed by the Texas Legislature in 1987 and amended in 1995 and 1997, PRPC adopted written investment policies on August 23, 1996 for funds under our control. In accordance with this Act, the investment officer of PRPC, which is the Finance Director, is required to submit to the Board of Directors a quarterly report of investment transactions. The following is a report, which was prepared in compliance with generally accepted accounting principles, of PRPC's portfolio from January 1, 2023 through March 31, 2023.

The money market funds are deposited at Amarillo National Bank. The PRPC fund earned an average annual yield of 3.91% for the quarter. The 9-1-1 fund earned an average annual yield of 3.03% for the quarter. The book value and the market value were the same for each fund listed above. The investment portfolio was in compliance with the Public Funds Investment Act and PRPC Public Funds Investment Policies throughout the quarter.

BACKGROUND

Per the Board discussion in March concerning investment of PRPC funds, I have developed an Investment Policy for your approval.

RECOMMENDATION

Staff recommends that the Board of Directors accept this Policy as submitted.

Panhandle Regional Planning Commission Investment Policy

Purpose

This policy establishes investment objectives, policies, guidelines, and eligible securities related to all assets held by the Panhandle Regional Planning Commission. In doing so the policy:

- Clarifies the delegation of duties and responsibilities concerning the management of these funds.
- Identifies the criteria against which the investment performance of the organization's investments will be measured.
- Communicates the objectives to the Board, staff, investment managers, and funding entities that may be involved.
- Confirms policies and procedures relative to provide the highest investment return with the maximum security while meeting PRPC's daily cash flow demands and conforming to all federal, state and local statutes governing the investment of public funds.
- Serves as a review document to guide the ongoing oversight of the management of the organizations' investments and investment policy.

Delegation of Responsibilities

The Board of Directors has a direct oversight role regarding all decisions that impact the Panhandle Regional Planning Commission funds. The Board has delegated supervisory responsibility for the management of our funds to the Finance Director. Specific responsibilities of the various bodies and individuals responsible for the management of our funds are set forth below:

Responsibilities of the Board

The Board shall ensure that its fiduciary responsibilities concerning the proper management of Panhandle Regional Planning Commission funds are fulfilled through appropriate investment structure, internal and external management, and portfolio performance consistent with all policies and procedures.

Responsibilities of Management

Management shall be responsible for the day-to-day administration and implementation of policies established by the Board concerning the management of funds. Management shall also be the primary liaison between any investment consultants and/or other outside professionals that may be retained to assist in the management of such funds. Management shall comply with official accounting and auditing guidelines regarding due diligence and ongoing monitoring of investments. These detail and summary reports will be prepared and presented to the PRPC's Board of Directors and Executive Director monthly. Reports will comply with Section 2256.023 of the Public Funds Investment Act at a minimum.

Investment Considerations

Investments shall be made with judgment and care, which persons of prudence, discretion and intelligence would exercise considering the probable safety of capital as well as the probable income to be derived. The strategy of the pool is to assure cash flows are matched with adequate liquidity.

The primary objectives, in priority order, of PRPC's investment activities shall be:

- Safety of principal is the foremost objective of the investment program. Investments of the PRPC shall be undertaken in a manner that seeks to ensure the preservation of capital.
- Liquidity: the PRPC's investments will remain sufficiently liquid to enable the PRPC to meet all operating requirements which might be reasonably anticipated.
- Investments will be limited to relatively low risk investments in anticipation of earning a fair return relative to the risk being assumed.

Guidelines for Investing

The Finance Director may invest in:

- Interest Bearing Money Market Accounts at PRPC's designated depository bank;
- CDAR's Not to exceed a year in duration; or
- Such other investments as the Board of Directors may authorize that are in accordance with federal and state laws and local statutes.

Expenditure of Investment Income Funds

All expenditures of investment income funds must assess the rules, uses, benefits, purposes, and duration for which the fund was established.

BACKGROUND

Beginning in 2007, the PRPC, with the support and approval of the region's jurisdictions, used approximately \$8 million in State Homeland Security Program funding to construct a new P25-capable interoperable public safety communications system to serve the entire Panhandle region. The system is named PANCOM and 231 responder agencies in the region use the system for public safety communications purposes. The system supports routine daily communications and emergency response; as well as interoperable communications for multi-agency, multi-jurisdictional response to large-scale disasters (including those involving terrorism). Both local and state agencies operating in the region rely on this system for radio communications.

The Panhandle region's user radio equipment currently used is predominantly conventional VHF narrowband with a number of agencies using APCO Project 25-compliant (P25) digital user radios and their numbers continue to grow. This is because the PANCOM system can accommodate both; it is a P25-capable system. The system also provides redundancy to the region's 911 system so all 23 PSAPs in the region utilize PANCOM as well. Components include a region-wide networked conventional VHF P25 repeater infrastructure consisting of forty-two 3-channel repeater sites, twenty-five 2-console PSAP dispatch sites, a Network Operations Center (housed at PRPC), associated microwave backhaul sites and links that tie all of the repeaters and PSAPs together. After years of effort, PANCOM finally achieved its chief goal of bringing the entire region into an interconnected P25 compatible narrowband system in 2013.

The PANCOM system is made up of 60 towers across the 26 County region. Which includes 25 privately owned towers, 15 water towers and/or local government owned towers and 10 PRPC owned towers. PRPC leases space on the privately owned towers with the PANCOM equipment to keep communication flowing. In addition to placing the PANCOM equipment on the PRPC owned towers, we also lease space out to other entities. The rent collected helps to lower the overall costs of maintaining the entire PANCOM system. And, as additional funding is made available through grant opportunities, PRPC will seek out those funds to purchase additional towers and drive

down the lease costs as we are able. Through a combination of SHSP funding, 911 contributions and fair-share contributions, the PANCOM system is truly a regional project. Showing that when we all work together it works better and is more affordable.

In 2017, Potter and Randall Counties began upgrading their local systems to 700/800 MHz. Nevertheless, in the years to come mutual aid will continue to flow in and out of the 2-county area. When outside agencies respond into the 2-county area; they'll be talking on the PANCOM system. When agencies within the 2-county area respond out of the area, they'll be talking on the PANCOM system. Though we have a disparate system within a regional system; all Panhandle agencies continue to share a communications connection through PANCOM. Although a handful of Panhandle jurisdictions have now converted to 700/800 systems, they continue to rely on PANCOM during mutual aid responses. PANCOM also provides redundant capabilities to the region's 9-1-1 system. The PRPC now maintains this system on behalf of the region's first responder community.

Now that it's been completed, the PANCOM system must be regularly maintained in constant good repair so it will continue to meet the communications needs of the region's first responder agencies. The PRPC has committed to maintaining the PANCOM system on behalf of the entire region.

PANCOM has been operational for over 15 years giving our first responders better communication. PRPC intends to keep PANCOM around for many more years. As many of you already know, if you have a break in communication please give us a call. Shane does his best to get things in working order quickly after a storm, line cuts or just normal wind shifting of the equipment.

- JJ (Juvenile Justice)
 - Texas State 421 Funds; and
- TP (Truancy Prevention)
 - Texas State 421 Funds; and
- VAWA (Violence Against Women Act of 2005)
 - US Congressionally Appropriated

In October 2022, the CJAC met to review, discuss and amend their bylaws to begin the FY 2024 grant making process.

In December of 2022, the Public Safety Office (PSO) of the Governor's Office solicited applications for criminal justice projects during the state fiscal year 2023 grant cycle. On December 13th, PRPC staff distributed a Notice of Fund Availability to 472 eligible entities in the Panhandle Region. Workshops were held on January 3rd and 5th to assist applicants with their application composition and submission. Virtual make-up workshops were also held on January 9th, 18th, 25th, 30th and February 1st for those who were unable to attend the in-person workshops. There were 39 attendees combined between the workshops. PSO set the application deadline on February 9, 2023.

PSO received one (1) grant applications under the VAWA category. The CJAC met on March 28th to hear oral presentations and prioritize application for the Victim Services categories. PSO received twelve (12) grant applications under the JAG and one (1) grant application under TP category from the Panhandle Region. There were no applications received under the JJ category. The CJAC met on April 10th to hear oral presentations and prioritize applications under the TP and JAG categories.

Final appropriations and grant funding determinations will be made by PSO and should be announced before September 1, 2023.

RECOMMENDATION:

BACKGROUND:

Each year, the Office of the Governor's, Public Safety Office (PSO) contracts with the PRPC to facilitate the distribution of the following Criminal Justice Assistance grant funds:

• VOCA – (Victims of Crime Act of 1984 & 2005)

• US Congressionally Appropriated;

With the last agenda item, this body was presented with the priority ranking that the CJAC approved at their March 28th meeting for the VOCA projects. At that meeting, the CJAC met and reviewed applications and heard presentations from the FY2024 VOCA grant applicants. A funding recommendation was made by the CJAC in regards to distribution of funds should the region not receive enough funds to fully fund each project in the amount in their original applications. On April 5, 2023 a Notice to Applicants and to regarding the outcome of the VOCA prioritization process was sent out to all VOCA applicants and the CJAC. On April 12, 2023 an appeal regarding the funding recommendation was filed with PRPC's Executive Director. Regional Government Services Staff consulted with the Panhandle Regional Planning Commission's (PRPC) Executive Director regarding the appeals process and the Office of the Governor's, Public Safety Office (PSO) regarding their opinion.

The appeals process states that the PRPC Executive Director decides on a course of action taken when an appeal is received. PRPC's Executive Director asked that the CJAC have an emergency meeting to review the appeal and re-evaluate the funding recommendations with this additional information. As always, the recommendation passed by the CJAC is only a recommendation. The PRPC Board of Directors has the latitude to review all aspects and can approve as they deem appropriate.

The CJAC will hold an emergency meeting on April 20th to review the information provided in the appeal, engage in discussion and vote on their funding recommendations. PRPC staff will have an updated funding recommendation chart at the PRPC Board meeting that will reflect the CJAC's decision for recommendation to the PRPC Board of Directors.

The recommendation on funding for the region's FY2024 VOCA projects from the PRPC Board of Directors will be sent to the Office of the Governor's, Public Safety Office. Those submissions are due no later than May 5, 2023. Final appropriations and grant funding determinations will be made by PSO. PRPC expects to receive those announcements around September 1, 2023.

RECOMMENDATION:

PRPC staff recommends the Board of Directors approve of the CJAC's recommended Grant Funding Recommendations for the Victims of Crime Act (VOCA) applications and authorize their submission to the PSO.

SUBJECT: Agenda Item 12 Presentation and Update on the Kick-Off Event for the PRPC Regional Infrastructure Accelerator Program

BACKGROUND

Beginning in 2007, the PRPC, with the support and approval of the region's jurisdictions, used approximately \$8 million in State Homeland Security Program funding to construct a new P25-capable interoperable public safety communications system to serve the entire Panhandle region. The system is named PANCOM and 231 responder agencies in the region use the system for public safety communications purposes. The system supports routine daily communications and emergency response; as well as interoperable communications for multi-agency, multi-jurisdictional response to large-scale disasters (including those involving terrorism). Both local and state agencies operating in the region rely on this system for radio communications.

The Panhandle region's user radio equipment currently used is predominantly conventional VHF narrowband with a number of agencies using APCO Project 25-compliant (P25) digital user radios and their numbers continue to grow. This is because the PANCOM system can accommodate both; it is a P25-capable system. The system also provides redundancy to the region's 911 system so all 23 PSAPs in the region utilize PANCOM as well. Components include a region-wide networked conventional VHF P25 repeater infrastructure consisting of forty-two 3-channel repeater sites, twenty-five 2-console PSAP dispatch sites, a Network Operations Center (housed at PRPC), associated microwave backhaul sites and links that tie all of the repeaters and PSAPs together. After years of effort, PANCOM finally achieved its chief goal of bringing the entire region into an interconnected P25 compatible narrowband system in 2013.

The PANCOM system is made up of 60 towers across the 26 County region. Which includes 25 privately owned towers, 15 water towers and/or local government owned towers and 10 PRPC owned towers. PRPC leases space on the privately owned towers with the PANCOM equipment to keep communication flowing. In addition to placing the PANCOM equipment on the PRPC owned towers, we also lease space out to other entities. The rent collected helps to lower the overall costs of maintaining the entire PANCOM system. And, as additional funding is made available through grant

opportunities, PRPC will seek out those funds to purchase additional towers and drive down the lease costs as we are able. Through a combination of SHSP funding, 911 contributions and fair-share contributions, the PANCOM system is truly a regional project. Showing that when we all work together it works better and is more affordable.

In 2017, Potter and Randall Counties began upgrading their local systems to 700/800 MHz. Nevertheless, in the years to come mutual aid will continue to flow in and out of the 2-county area. When outside agencies respond into the 2-county area; they'll be talking on the PANCOM system. When agencies within the 2-county area respond out of the area, they'll be talking on the PANCOM system. Though we have a disparate system within a regional system; all Panhandle agencies continue to share a communications connection through PANCOM. Although a handful of Panhandle jurisdictions have now converted to 700/800 systems, they continue to rely on PANCOM during mutual aid responses. PANCOM also provides redundant capabilities to the region's 9-1-1 system. The PRPC now maintains this system on behalf of the region's first responder community.

Now that it's been completed, the PANCOM system must be regularly maintained in constant good repair so it will continue to meet the communications needs of the region's first responder agencies. The PRPC has committed to maintaining the PANCOM system on behalf of the entire region.

PANCOM has been operational for over 15 years giving our first responders better communication. PRPC intends to keep PANCOM around for many more years. As many of you already know, if you have a break in communication please give us a call. Shane does his best to get things in working order quickly after a storm, line cuts or just normal wind shifting of the equipment.

- SUBJECT: Agenda Item 13 Consideration of a Resolution to Support the Purchase of the Workforce Development Building at 3120 Eddy St. Amarillo

BACKGROUND

Regional Councils of Government are created under Chapter 391 of the Texas Local Government Code. The purpose of Regional Councils is to "Join and cooperate to improve the health, safety, and general welfare of their residents and Plan for the future development of communities, areas, and regions". Chapter 391 goes on to speak about recognizing the needs of agriculture, business and industry as well as building essential facilities to help communities, areas and regions grow.

PRPC's Workforce Development Department provides workforce development and child care services for the Panhandle region through Workforce Solutions Panhandle (WSP). This relationship has translated successfully into a significant and meaningful impact to both local and regional economics where employment opportunities are fulfilled by a trained, skilled and development workforce. In 2022, WSP served an average of 1,983 children daily, provided services to 10,668 area employers, created 4,228 job orders, made 18,333 job referrals, hosted 144 hiring events, and completed 4,374 total job placements, currently operating in Amarillo, from a leased facility at 3120 Eddy Street.

In 2021, PRPC was awarded an Economic Development Administration (EDA) grant of \$2.5M for the purchase of the Eddy Street facility, as well as to make building improvements consisting of parking lot repairs, installation of a bus stop and shelter, and updating the interior HVAC controls system. The purchase of the facility would allow the Workforce Development Department to redirect the lease funds back into service delivery and thereby increases the efficiency and effectiveness of the Workforce Development programs.

A matching contribution for the EDA grant of approximately \$550,000, is required. The purpose of this agenda item is to allow the PRPC Board of Directors to support efforts to seek out and find external partners to raise the necessary capital to match the EDA grant and to facilitate the purchase of the Eddy Street facility.

RESOLUTION

A RESOLUTION BY THE BOARD OF DIRECTORS OF THE PANHANDLE REGIONAL PLANNING COMMISSION (PRPC) RECOGNIZING AND SUPPORTING THE PURCHASE OF THE WORKFORCE DEVELOPMENT BUILDING AND THE PURSUIT OF ESTABLISHING PARTNERS TO RAISE THE NECESSARY CAPITAL TO FACILITATE THE PURCHASE.

WHEREAS, the Texas Panhandle is in need of the continuation of Workforce Development programs to train the region's workforce to serve the urban and rural areas and continue to focus on economic growth and prosperity in the region; and

WHEREAS, the regional economy is built on an over-reliance of agriculture and oil, and in order to foster economic resiliency and diversity, Workforce Development programs are necessary to train and invest in the labor force throughout the region; and

WHEREAS, the Workforce Development building is home to Workforce Solutions Panhandle (WSP). WSP provided services to 10,668 area employers, created 4,228 job orders, made 18,333 job referrals, and completed 4,374 total job placements. Workforce Solutions Panhandle is integral to the economic impact created when the Panhandle region's employment opportunities are fulfilled by a trained, skilled and developed workforce; and

WHEREAS, the Texas Panhandle region would benefit from additional services that will be available through the purchase of the building which will eliminate unnecessary costs (approximately \$500,000 annually) associated with rent payments; and

WHEREAS, the Panhandle Regional Planning Commission has received a grant from the Economic Development Agency (EDA) for \$2.5M to assist in the facilitation of the purchase of the Workforce Development building; and

WHEREAS, the EDA grant project requires a matching contribution of approximately \$550,000.00 to fulfill the grant requirements; and

WHEREAS, a Public Facilities Corporation will be investigated and researched and if deemed to be valuable and appropriate could be established to facilitate the purchase and administration of the Workforce building; and

WHEREAS, it is advantageous and desirous to partner with local and regional organizations and businesses to help raise the necessary capital to support the purchase of the Workforce Development building; and

NOW, THEREFORE, BE IT RESOLVED, that the Panhandle Regional Planning Commission Board of Directors supports efforts to partner with local and regional organizations to raise capital to allow for the purchase of the Workforce Development building to continue to provide a viable regional workforce development center, which includes sustainable workforce development training programs to spur regional economic development and expand economic opportunities throughout the region.
